<ul style="list-style-type: none"> <li>• Received a previous Low-Income Corporate, "PLUS"/Switcher or Individual scholarship in a previous academic year <b>and</b> continued to attend a qualified private school</li> <li>• Transferring from an Arizona public or charter school with at least 90 days of attendance in the public or charter school in the previous academic year or one full semester in the same year</li> <li>• Disabled preschooler enrolled in a qualified disabled preschool</li> <li>• Dependent of active duty military stationed in Arizona on orders</li> <li>• Entering kindergarten</li> </ul>	<ul style="list-style-type: none"> <li>• Children who have been attending private school and have not received a qualifying scholarship in previous years</li> <li>• Preschoolers other than those with disabilities</li> </ul>

**Displaced/Disabled Corporate Scholarship**

- For **preschool students** who have a public school IEP or MET or for **K-12** who have a public school IEP, MET or 504 plan or have been in Arizona state foster care system.

Eligible (Must meet a minimum of 1 requirement)	Ineligible
<ul style="list-style-type: none"> <li>• Student has an IEP, MET or 504 plan from an <u>Arizona</u> public school;</li> </ul> <p><b>OR</b></p> <ul style="list-style-type: none"> <li>• Student was placed at one time in the Arizona foster care system (to be verified by the Arizona Department of Economic Security)</li> </ul>	<ul style="list-style-type: none"> <li>• Displaced preschooler</li> </ul>
