



# **GUIDE FOR CLAIMING YOUR 2025 PRIVATE SCHOOL TAX CREDIT ON TURBOTAX!**



## STEP 1

### Determine Your Donation Amount

- Enter tax information in Turbo Tax without listing your Private School Tax Credit
- Once your State taxes are finished, but not yet filed or ... taxes are almost finished you will see something similar as to the right
- Your "Income Tax" is your Arizona State liability
- You can donate Arizona tax credits up to your Arizona State liability (this includes ALL State tax credits as well as Dependent & Family income tax credits) but not donating more than the program's maximums:
  - **Filing single** \$1,535.00
  - **Filing jointly** \$3,062.00
- Once you determine your donation amount (recommend a student, school or most needed) click on "Your State Returns" on the left panel of TurboTax

## STEP 2

### Status of Your Returns

- Once navigated to the status, click on "Edit"
- Click through until you reach the School Tax Credit Section

## STEP 3

### School Tax Credits

- Select "I donated to an Arizona private school by April 15, 2026"
- Click "continue" until you reach Contributions to Private School Tuition Organization, enter IBE's information and click continue

## STEP 4

### Contributions to Private School Tuition Organizations

- Fill out this form and click "continue"
- Once all Private School tax credit donations are listed, click "done"

### If you have already made your 2025 tax credit donation

- Continue through your state tax form until you reach the School Tax Credit section
- Click "I donated to an Arizona private school by April 15, 2026"
- Fill out this form and click "continue"
- Once all Private School tax credit donations are listed, click "done"
